

Marta Dragičević Prtenjača is currently an assistant professor at the Department of Criminal Law at Faculty of Law University of Zagreb since 2015. She passed the Bar Exam in 2007. She graduated in 2004 at Faculty of Law University of Zagreb. Doctoral thesis on 'Criminal perspective of passive bribery in Croatian legal system' was defended in 2014. at the same faculty. She worked as a lawyer trainee (2005-2007); a scientific novice researcher on the project "Criminal Law Prevention of Corruption and Organized Crime", headed by prof. dr. sc. Davor Derenčinović at the Faculty of Law, University of Zagreb (2007 - 2009); was assistant lecturer at the Department of Criminal Law of the Faculty of Law, University of Zagreb (2009 -2014); Senior Assistant at the same Department (2014-2016), and is currently an assistant professor at the same Criminal Law Department (since 2016). Further academic training and improvement received at the following institutions: The Syracuse International Institute, the European Law Academy in Trier, and Max Planck Institute for Foreign and International Criminal Law in Freiburg, and on international courses in Croatia named 'Crime Prevention through Criminal Law & Security studies'. She is a member of the Croatian Association for Criminal Sciences and Practice; Croatian Association for European Criminal Law; a replacement member of the Commission on Corporate Responsibility and Anti-Corruption, ICC –Croatia; a member of the European Society of Criminology; and Member of the Max Planck Partner Group 'Balkan Criminology'. She was a member of the task force for drafting 'ICC Guidelines on Conflicts of Interest in Enterprises' as one of the projects of the Central ICC Commission on Corporate Responsibility and Anti-Corruption in Paris (2015-2018). Was a member of the task force (working group) for drafting the Law on the legal consequences, criminal records and rehabilitation; a member of the team on the project IPA 2008 "Improving the Capacity of the University System to Create a Framework for Preventing Discrimination and Corruption aimed at Improving Academic Integrity" (2012-2013), and was a member of the research team at international - scientific project "WISKOS" conducted by the Max Planck Institute for foreign and international criminal law, approved and financed by the German Government (2015-2018). She was one of the Executive –Editors of the Yearbook Croatian Academy of Legal Sciences (2015-2018). She participated in the development of today's Criminal Code as an external associate of task force for drafting the Criminal Code and in 2018 she was a member of the task force for amendments of the Criminal Code, and was a researcher on the project "Multidisciplinary Research Cluster on Crime and Transition - Trafficking in Human Beings, Corruption, and Economic Crime". She has published several scientific papers on different topics from criminal law, and was a mentor of more than 30 graduate theses. Teaches Criminal Law (lectures, seminars, and exercises), Juvenile Criminal Law, and Misdemeanour Law (Minor Offences Law) at Faculty of Law, University of Zagreb.
